

Privacy Policy

This website, www.wisertogether.com, (the "Site") is owned by WiserTogether, Inc. (hereinafter referred to as "WiserTogether", "we", "us", or "our"). We take the privacy of the visitors to our Site (hereinafter referred to as "you" or "your") seriously, so we have drafted this statement ("Privacy Policy") to outline the type of information that we collect from you, how we use such information, and how you can request that we delete or update your personal information.

In general, the Site is intended to be used by you to gain information about our company, products and services (hereinafter referred to as "Company Information").

Your Consent

You accept and agree to the terms of this Privacy Policy by using the Site. If you do not agree to the terms of this Privacy Policy, please cease use of the Site. This Privacy Policy only applies to the information obtained through this Site. A separate agreement between you and WiserTogether shall govern any information provided to or received by us by means other than through this Site.

Information Collected

Much of the Site may be visited without providing personally identifiable information. Our primary goal in collecting personal information from you is to be able to provide you with the contact or Company Information requested by you through the Site. By submitting personally identifiable information through the Site you may request to be contacted by WiserTogether, you may sign up to receive our newsletter, you may apply for employment with us, and you may request a demonstration of our products and services. In order to provide you with the requested contact or Company Information, the Site may ask you to provide certain personally identifiable information such as your name, address, email address, telephone number, etc. ("Personal Information"). You may always decide not to provide certain information, but you may not be able to move forward with your request. You will be told what information is optional and what information is required.

Use of Information Collected

We may use the Personal Information collected about you to: (1) communicate with you about Company Information; (2) process, evaluate and respond to your inquiries and requests; (3) manage our communications; (4) analyze and enhance the Site and our products and services.

Disclosure of Information Collected

We will not sell your Personal Information to third parties. We will only disclose your information to third parties in the following instances: (1) to respond to a legally valid request by government authorities or law enforcement; (2) to enable any third party with whom we have contracted for communication services to contact you to fulfill your request; and (3) as part of an acquisition of WiserTogether's business or in the event of a merger.

Use of Cookies

"Cookies" are small pieces of information that a website sends to your browser while you are viewing a website. A cookie file is stored in your web browser and allows the Site or a third party to recognize you. Cookies can be "persistent" (which stay on your browser until you delete them) or "session" (which expire once you close your web browser) Cookies. We may use Cookies to gather information about your website activity, device and browser information and contact information. We may also allow our third party vendors to have these same capabilities. For example, a third party analytics vendor may use Cookies to track information for analytics purposes and a third party marketing firm may use Cookies to track information for marketing purposes. We may also use a third party tracking service to track and analyze Information from users of our Site. Such third parties may use Cookies to help track user behavior. The use of Cookies by third parties is not covered by our Privacy Policy. We do not have access or control over these Cookies. Cookies can be blocked or removed by following your Internet browser's help file directions. Please be aware that if you choose to disable Cookies, you may not be able to use certain features of the Site.

Children's Use

This Site is not directed to children under the age of thirteen. We do not knowingly collect personal information from children in this age group on the Site. If we become aware that we have inadvertently received personal information from a visitor in this age group, we will delete the information from our records.

Data Security

WiserTogether is committed to protecting your Personal Information submitted to us via the Site. We maintain administrative, technical and physical safeguards to protect against unauthorized disclosure, use or alteration of your Personal Information. Partners, contractors and vendors who

have access to your Personal Information in order to provide services to us are only permitted to use such information to provide these services and are required to keep such information confidential.
